1. Purpose of the report/Strategic issue for consideration

1.1 Present the Vision Zero South West (VZSW) financial position as at 31st July 2024.

2. Recommendation

2.1 The Board be made aware of the financial position as at 31st July 2024.

3. Salient Points

3.1 The Office of Police & Crime Commissioner (OPCC) is the lead financial party for the Vision Zero South West collaboration. A balance of £4.38m was held in a ringfenced reserve at the start of the financial year.





Vision Zero South West Forecast – Running Costs

- 3.2 The Partnerships planned net expenditure, before any capital spending, was originally predicted in the 5-year plan to be a surplus of £103,441. The table below summarises the forecast income and expenditure and shows a forecast surplus position of £274,354. Since the surplus predicted in the 5-year plan this is an increase of £170,913. The main drivers being an increase accident report income and reduced staffing costs due to recruitment and vetting.
- 3.3 A full detailed breakdown of this can be found in Appendix A.

- 3.4 During the first four months of the financial year, income generated from Speed Awareness Courses of £1,669,088 is higher than budget expectations by £208,906, and currently exceeds last year's income at this point by £219,261.
- 3.5 The graph in Appendix B displays income levels by month and splits out the additional £10 of income the Partnership receives from training provider TTC for the increased course fees. Forecast income for the next two months is based on current levels of referrals.
- 3.6 Court costs recovered are expected to end the financial year at a similar level to the budget at £970,000, so far £347,728 has been received.
- 3.7 Income generated from Accident Reports is trending higher than originally expected, with a forecast of £230,000 and £102,542 being received so far.
- 3.8 Staffing expenditure is forecast to reduce by £144,910, mainly caused by vacancies due to recruitment delays within the offence processing team.





- 3.9 Running costs are forecast £15,350 higher than budget due to an increase in Software Licences, mainly caused by inflated costs and Community Speed Watch body warn video cameras.
- 3.10 VZSW core costs are expected to increase by £7,575 compared to budget. The Speed Maintenance Contract & Maintenance forecast has increased by £48,500 due to a 4% contract price rise and additional cameras this financial year, offset by reduced costs of the core team due to recruitment delays.

Vision Zero South West Forecast – Pooled Fund

3.11 At the start of the financial year the opening balance of the reserve was £4,378,136. The Partnership is expecting to invest a spend of £3,022,417 during the year; including the transfer of surplus of £274,354 this will result in an expected closing balance on 31st March 2025 of £1,630,073.

- 3.12 The remaining previously approved expenditure will fall into future years. The available balance after the approved and ringfenced amounts is £1,167,756.
- 3.13 Investment in vehicles of £407,939 is expected to be made during the year. This includes the purchase and fitting out of the remaining delayed speed detection vans and the RCRO Engagement Van.





- 3.14 £214,703 investment in camera equipment, mainly for the Roadside AI Trailer which has started to be deployed.
- 3.15 Activity B spend of £975,168 is expected this financial year. This includes the following as detailed in the Road Safety Delivery Plan.
 - £129,434 on Motorcyclists
 - £380,000 on Post Crash Response and Care
 - £79,932 on Younger Drivers
 - £116,886 on Pedestrians
 - £65,000 on Cyclists
 - £29,917 on Older Drivers
 - £156,339 on Call for Ideas Phase 2
 - £17,660 Contingency Fund
- 3.16 £206,109 of the Comms and Engagement budget is expected to be spent this financial year, so far £36,372 has been spent.
- 3.17 The Board agreed to hold £1,500,000 to fund the upgrading of camera stock, with £1,168,498 remaining to be spent this financial year. Several new camera systems are now installed with further systems expected in the next couple of months.

4. Conclusion

- 4.1 Income for the first four months of the financial year is higher than budget expectations, in addition to staffing costs being lower than expected; a surplus of £274,354 is now anticipated.
- 4.2 After accounting for expenditure already approved the available balance on the Pooled fund is £1,167,756.

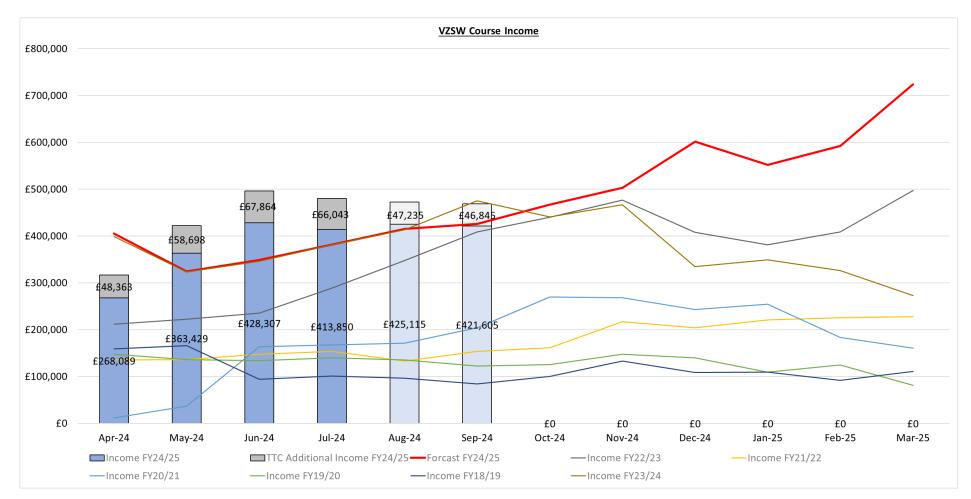

Recruitment Update

Commissioning Manager – Since approval, commissions continue to be managed via Partners. Confident that ad hoc support with recharge if required, is sufficient.

Recommendation: Remove post from Financial and 5- Year Business Plan

Road Safety Team Restructure - Staffing structure not yet in place due to delays in vetting

Strategic Analyst – Force change in design agreed, advert and interview documentation being prepared

Intel Researcher – Force change in design agreed and advert being prepared



PPM Role – to be the conduit between Force Planning and Analysis Teams and VZSW Board for performance reporting

- Development of strategy to support objectives
- Business planning
- Risk identification and management
- Performance monitoring / framework development



Recommendation: Proceed with recruitment to secure a role on a permanent 0.5 FTE contract*

*Ideal scenario is 0.5 FTE but seeking approval for upper limit of 0.8 FTE to mitigate risk of this not attracting applicants – advert to indicate hours negotiable with prior discussion.

Activity A – Distracted Driving Trailer

Deployment commenced end of July (data below collated up to end of August)

- Taking advantage of favourable weather, 3 trailers located at same time A361 (Barnstable to Braunton), A38 (Landrake) and A388 (nr Kelly Bray).
- <u>A361</u> –**1799** 2nd reviews accepted for possible offences **1363** seat belt and **436** mobile phone
- <u>A38</u> **1709** 2nd reviews accepted for possible offences **1150** seat belt and **559** mobile phone
- <u>A388</u> **812** 2nd reviews accepted for possible offences **645** seat belt and **167** mobile phone





Activity A – Distracted Driving Trailer

- Approximately 0.3% of the vehicles checked were either not wearing a seatbelt and/or using mobile phone)
- Of offences detected 73% seatbelt and 27% mobile phone.
- Worrying trend noted for children unrestrained in front seat – process being developed to conduct follow up safeguarding
- Next two sites will be in Torbay and Plymouth (October)



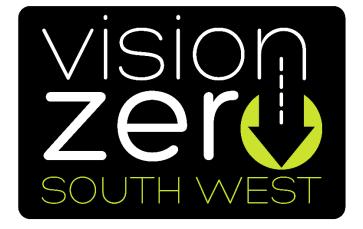

RSDP Tracker

Full tracker included within Board Pack setting out key highlights on all activity:

- Includes all approved activity with additional initiatives added between Sept 2023 -June 2024
- Completed projects where reporting no longer required removed from plan
- Item 8 on agenda extends RSDP to March 2025 when new plan will be presented
- Delivery highlights on activity to follow



- New tool for triage: by bystanders: under review by BMJ Open for open access publication.
- **TXA Pilot:** Letter and suggested communications developed. Next step is to secure University ethics to enable qualitative evaluation with selected blue light responders.
- **Cold Case Review:** Proving difficulty to obtain records, Road Injury Pilot looking at alternative data capture in survivors.
- Post-collision centre <u>www.post-collision.com</u>: Financial meeting held. Reporting template for audit purposes to be developed/agreed, setting out activity & spend against both annual enabler fund & one-off Development Fund.



Programme split into three areas:

- Community Safety Grant process complete and resources issued
- Vehicle Activated Signs 2 locations supported in Torbay, and 3 potential sites (2 Devon & 1 Cornwall) progressing
- **Pedestrian** a range of initiatives are planned utilising £100,000 agreed funds
 - **Torbay** In the academic year 23/24 10 primary schools received training. Further funding means that the delivery can hopefully be extended to a further 21 schools in 24/25.
 - **Plymouth** based on collision data and site visit, two locations chosen for comms focus.
 - A draft plan has been developed/costed to support potential 'light touch' engineering improvements – subject to funding



- **Pedestrian 'Call for Ideas' –** continued:
 - Cornwall Casualty data shows higher than expected number of injuries near formal crossing facilities
 - Literature review completed, content to focus on general pedestrian safety (including distractions)
 - Filming local footage in August to use as hazard awareness clips/educational materials (ready in September)
 - Year 6 to receive in June, Year 7 early into academic year, so in quick succession to build on their learning
 - Evaluation will take place over a longer period obviously.



- Devon County Council Walkability trained 300 children so far. Active Devon (Provider) on track with ambitious target of 3,500 children in 24/25. Press release planned for September.
- **Plymouth Pedestrian Programme** continues, approximately 700 children have been trained to date and it is estimated that 800 children will be trained from September 2024 to July 2025 with a further 500 between September 2025 and the end of April 2026
- Cameras for Cyclists Some residual funding left within Plymouth and Torbay to continue delivery until March 2025
- Cycle Cluster Site Signage Torbay have installed at 3 sites, Devon installing at 3 sites, Cornwall installing a trial location and Plymouth looking to renew some existing sites
- **Behaviour Change** Claremont procured via tender for Behaviour change completion date is 29 November 2024.



Activity B – Motorcycle

- Motorcycle EOI claims continue and programme will end March 2025 when summary
 of those trained will be provided
- Docuseries working with RiderCam and rider to document journey, includes personal story
- Biker Down Utilising remaining funds to continue delivery, evaluation of scheme will be provided at March Board alongside a long-term delivery plan
- Simulator hundreds of riders have tried simulation, national evaluation results ready next year.
- Intention is to continue to use for young riders through colleges & CBT centres
- BikeSafe continue to provide training but review underway on whether local version will be produced/delivered



Activity B – Older/Younger/ Business Drivers

- Older Driver Events completed by RCRO's at garden centres/supermarkets in Devon. Cornwall Mobility event taken place at Treliske Hospital in July with skills day at Perranporth Airfield (Sept TBC) working alongside agencies.
- DSFL presentation being rolled out by Cornwall Mobility to various groups across Devon and Cornwall.
- Younger Driver parent intervention Research concluded by Claremont. Next steps ongoing with view to submitting funding request to Road Safety Trust.
- Both L2L and StD continue to deliver, comprehensive evaluation of L2L starts in the Autumn
- Business Driver- review of partner driving to work policies completed and observations shared. DfBB provided link to Driving for Work Policy Template Builder to be shared on VZSW website
- Supporting D&C Police Commercial Vehicle Unit who are currently producing a presentation to roll out to small businesses within Devon and Cornwall. Focus on both vehicle roadworthiness and driver roadworthiness.

1.0 PURPOSE

1.1 To extend existing RSDP beyond August 2024 to the end of the financial year (March 2025) see appended document, schemes linked to 2.1 are highlighted.

2.0 RECOMMENDATIONS

- 2.1 That Partners:
 - **a.** Acknowledge the recommendation to extend timeframe of the RSDP to March 2025 and agree additional £30,000 funding required.

3.0 DEVELOPMENT GROUP ASSURANCE & STRATEGIC FIT

3.1 As the recommendation in this paper is linked to approved activity, only the financial element was discussed at the Development Group and satisfied it should be presented to VZSW Governance Board.

4.0 EXECUTIVE SUMMARY OF PROPOSAL

- **4.1** The five-year business plan approved in December 2023, made provision for an annual RSDP of up to £1m from April 2025 (subject to annual approval). The current plan covered 12 months Sept 2023 Aug 2024 and this paper recommends extending this to the end of the financial year. During the intervening period, approved activities will continue to deliver with approved funds, however, two workstreams require a 'top up'.
- **4.2 Younger Drivers** In March 2023, the Board approved £73,100 for the academic year 2023/24 and for Learn2Live (L2L) and Survive the Drive (StD) to become an annual commitment built into the 5-year business plan. Due to efficiencies in delivering more theatre style presentations as opposed to individual colleges, expenditure for 2023/24 was lower than projected.
- **4.3** Based on the remaining funding from 2023/24 and projected costs for the academic year 2024/25, increasing the existing Purchase Order by £20,000 will cover the continuation of this already approved activity. The RSDP to be presented next March will confirm the commitment for 2025/26. L2L will be subject to a comprehensive evaluation this autumn with outcomes to be presented to the Board; and is important in understanding future delivery recommendations.
- 4.4 Comms & Engagement Following a review of spend to date, we are confident that we can utilise remaining funds to extend activity to March 2025; with the exception of a £10,000 ask to continue delivery of Lift Legend in December. This scheme encourages licensed premises such as pubs to provide free soft drinks to designated drivers throughout December and is aimed at reducing instances of drink-driving. Participating venues are issued with free promotional merchandise supported by social media communications. Activity is now well advanced to engage licensed premises. Evaluation has been developed and outcomes will inform future delivery 2025 and beyond.

5.0 FINANCIAL REQUEST

5.1 To increase existing younger driver purchase order by £20,000 and add an additional £10,000 to the comms and engagement budget to cover Lift Legend.

6.0 IMPLEMENTATION TIMESCALE & NEXT STEPS

6.1 Subject to Board approval, the financial plan will be amended to reflect the decision to add £30,000 and partners will continue to deliver on agreed activities.

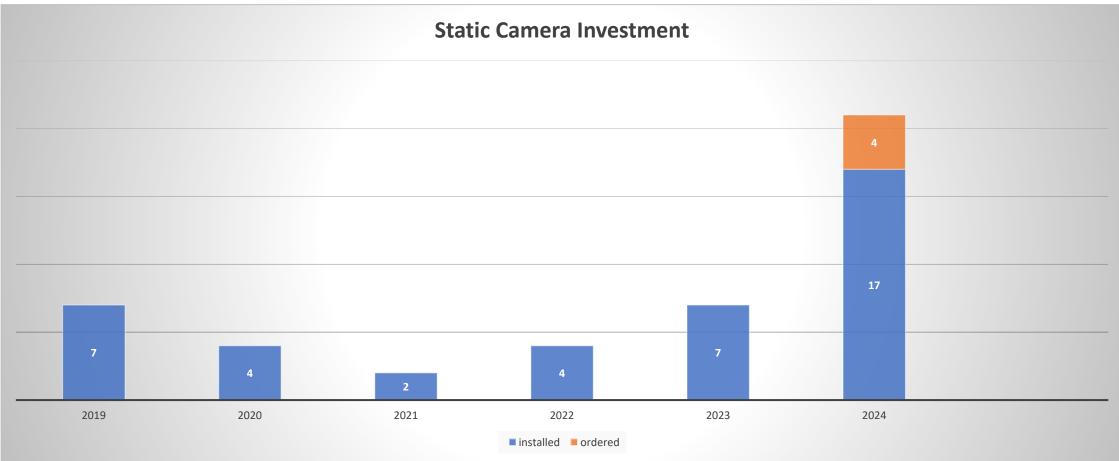

Mayor of Helston Miles Kenchington said the act was "illegal" and "a form of vandalism".



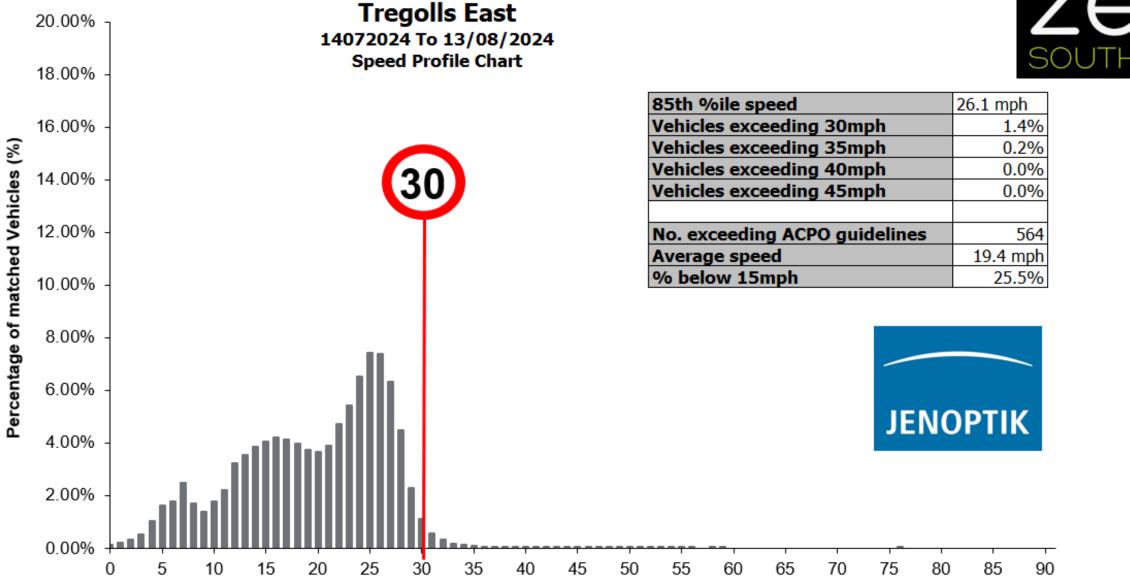

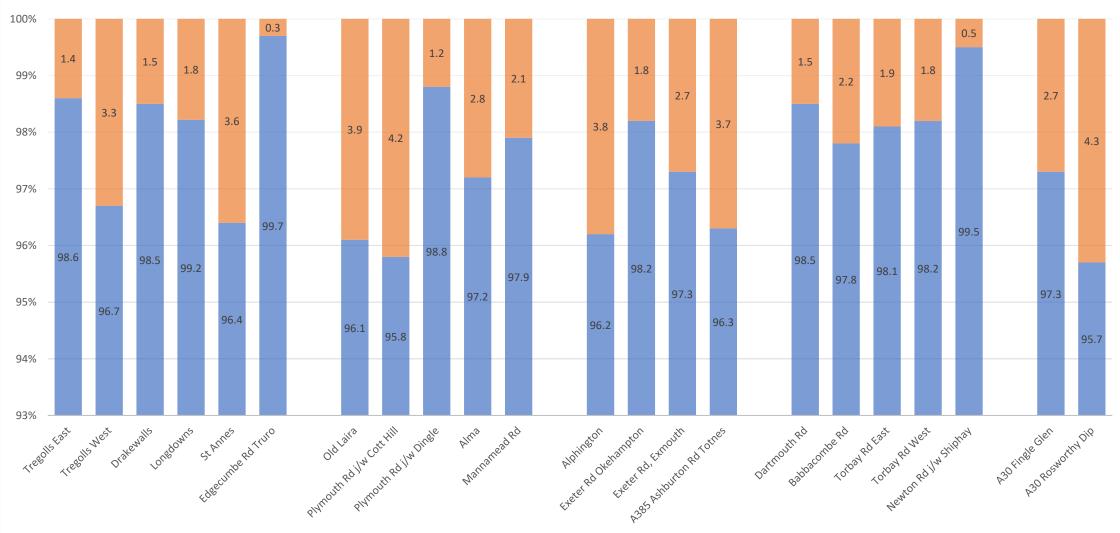
How effective, how quickly?

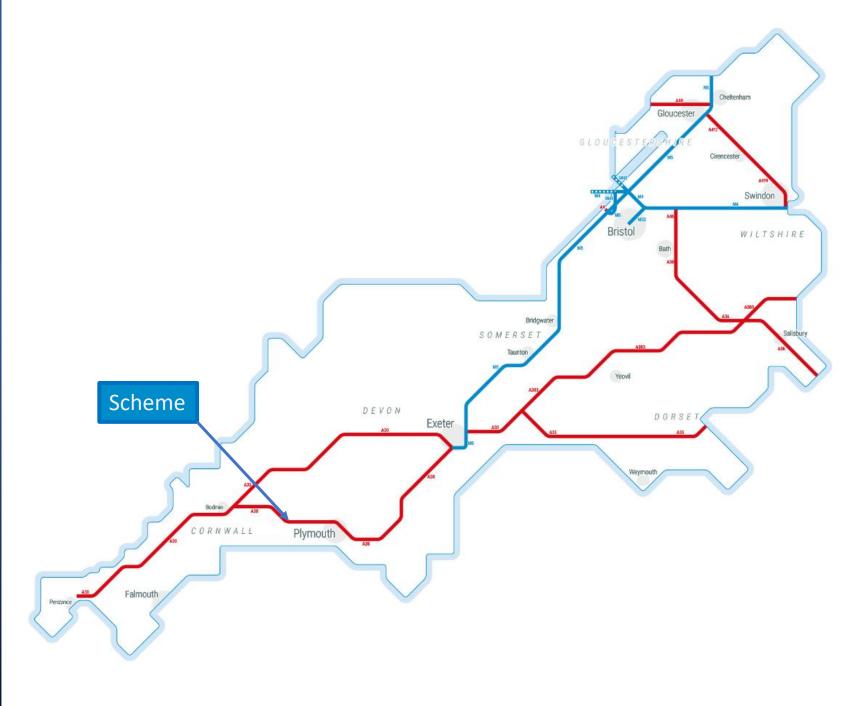

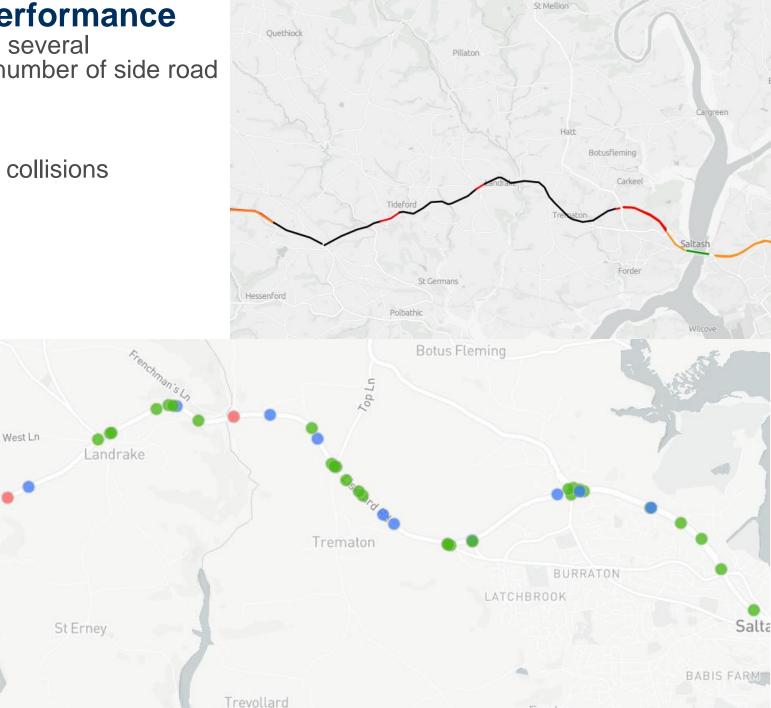

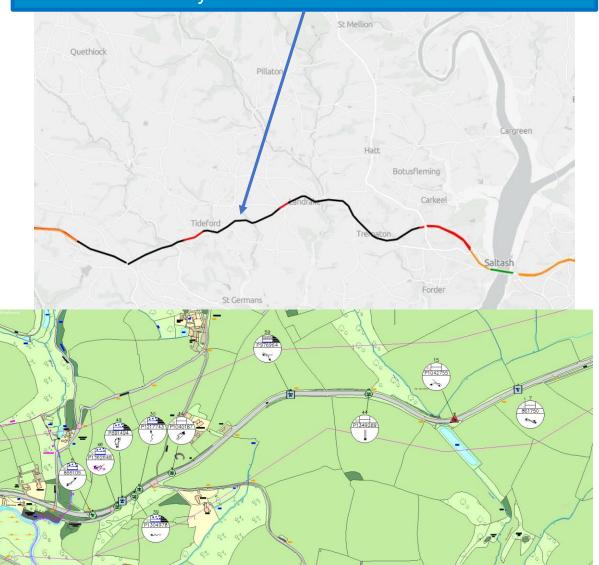

1.0 PURPOSE

1.1 To provide assurance with regards to general comms and engagement and to seek approval to take the next steps with regards to VZSW Lobby Plan and Week of Road Safety Action.

2.0 RECOMMENDATIONS

3.0 DEVELOPMENT GROUP ASSURANCE & STRATEGIC FIT

3.1 Following June's VZSW AGM where these items were agreed to be developed, work has progressed at pace. Outline plans have been discussed at the Road Safety Partnership Forum, followed by the Development Group; and satisfied that these should be presented to the Board for approval.

4.0 EXECUTIVE SUMMARY OF PROPOSAL

- **4.1 VZSW Lobby Plan** Appendix one (intend to publish) contains a draft letter as well as a graphical presentation of what we want to lobby our new Labour Government for. This 'Call for Action' is our lobbying plan setting out key issues and improvements to make our roads safer. The plan is set within the context of safe systems, setting out our aspirations within each pillar. Many organisations have already written to Government, such as PACTs who set out 4 priorities, but we have yet to see a request set out as a whole in this way.
- **4.2** The new government is still within its first 100 days, and it seems advantageous to seize the opportunity to send this during this period. Feedback from Board Members is welcomed, and intention is to publish documents on 27th September. Options to hand deliver copies of our plan are being explored.
- **4.3 Week of Road Safety Action** VZSW local activity is going to coincide with Brake's national campaign begins on Sunday 17th November; a day of remembrance for road victims. The theme this year is Post Crash and we will begin and end our activity targeting this theme. Discussions at the Board will run through potential activity and provide opportunity for Board Members to highlight areas they feel might be missing and that subject to further discussion and resource availability, could be included.
- **4.4** Activity will be within the context of the safe system pillars with various partners leading on some of the days.
- **4.5** Early into the Partnership transition, we carried out a Day of Action for the A38 which largely included enforcement and engagement activities. Our plan is to hopefully accommodate and

target a number of activities along the A38, given local community concerns and collision history. This will be supplemented by other activities happening across the two counties that are pre-determined/planned.

4.6 Appendix two, provides a general comms and engagement update.

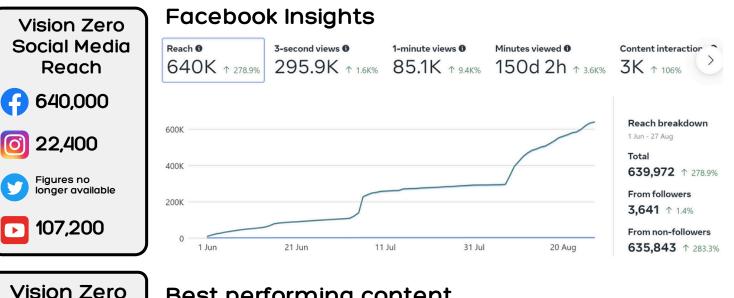

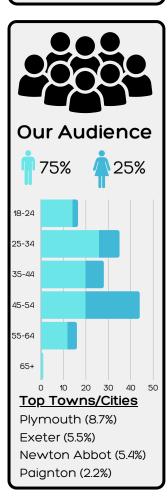

1.0 PURPOSE

1.1 The purpose of this paper is to seek Board approval for the creation of a Road Safety Investigations Team Supervisor role within the Road Safety Team, to supervise the activity and workload of the police investigations Team.

2.0 **RECOMMENDATIONS**

2.1 That Partners:

- Approve ongoing funding requirement for a Road Safety Investigations Team Supervisor.
- A 12-month review of the effectiveness of the post is provided to the VZSW Board in December 2025.

3.0 DEVELOPMENT GROUP ASSURANCE & STRATEGIC FIT

- **3.1** The overarching strategic aim of VZSW is to work together to drive changes that will prevent death and serious injury from occurring on the roads of Devon and in supporting the proposal set out in this report, this provides resilience and capacity to target the safe system pillar of safe speeds.
- **3.2** With a growing enforcement posture the number of camera generated offences dealt with by the road safety team has almost doubled within 3 years. This increase in offences and their processing has necessitated a rise in the back-office staff from 30 to 40 FTE posts. The investigator numbers have increased from 3 to 4 police officers, following VZSW Board approval in December 2023 alongside two existing PIP 2 qualified civilian investigators. It was agreed that it was logical to build in additional resource, however the increase in supervisory requirements for this team is beyond the scope of availability for the existing managers, overseeing 500 plus pervert the course of justice or other complex level 2 investigations in addition to managing the overall office.
- 3.3 Devon and Cornwall Police is currently under HMICFRS Peel (Police Effectiveness, Efficiency and Legitimacy 2023-2025 engagement review regarding the quality of our crime investigations. PIP 2 investigations are the most serious of crime categories and can only be heard at Crown Court and Investigated by PIP 2 accredited Officers (Detectives) and must be supervised by PIP 2 accredited line management.
- **3.4** The current managers do not hold that qualification as it must be continuously renewed on a triannual basis, to align with national standards.

3.5 Discussions of this proposal took place on 1st August 2024 at the Development Group with a paper prepared for review prior to presentation to VZSW Governance Board for approval.

4.0 EXECUTIVE SUMMARY OF PROPOSAL

- **4.1** Enforcing those who travel at excess speed is a fundamental element of targeting the 'Fatal 5' causes of fatal and serious injury collisions, through thorough investigation other offences are disclosed such as use of mobile phone use, driving without valid insurance, document offences such as no driving license, and disqualified drivers. Scrutinising motorists who have submitted false or misleading nominations we will ensure those who would seek to continue driving whilst avoiding the consequences are dealt with appropriately. The indication of this will be a reduction in the number of false nominations and subsequent Pervert the Course of Justice (PCOJ) investigations.
- **4.2** Sworn officers and two PIP 2 (civilian detective equivalent) investigators interrogate camera activations where there is evidence of such offences placing 'markers' on vehicles. These markers facilitate stops on offending vehicles by their colleagues on the No Excuse or Roads Policing teams. Often this results in the detection of wider criminality as criminals use vehicles to travel to and from burglaries or to transport drugs. It often results in vehicle seizures due to no insurance or license, or the prohibition of vehicles due to dangerous defects. By taking these dangerous or uninsured vehicles or unlicensed drivers off our roads we ultimately make our road safer.
- 4.3 There is also a growing use of 'NOIP farms' which has become a national issue for the police. NOIP (Notice of Intended Prosecution) farms allow individuals to pass their Notice of Intended Prosecutions (NOIP) on to an unknown individual for a fee. This is large scale organized criminality, earning those who run such schemes many thousands of pounds and allowing offenders to evade prosecution. By doing so they continue to drive on our roads 'immune' to speed camera detection and in doing so pose a greater risk. Additionally, the individuals who are ultimately nominated as the driver are often the most vulnerable in society who have no knowledge of any offence and are often fined or even disqualified from driving in their absence, hence without their knowledge. As a result of this growing trend forces are now sharing information on these NOIP farms requiring collaborative work and research on the individuals by our small team of police officers.
- 4.4 With detection increases, it follows that the percentage of those who will try and avoid the consequences of their actions will also increase. The additional Road Safety Investigations Team Supervisor will supervise the team who will deal with these drivers and where appropriate develop investigation plans for further action as required and necessary, providing focus and clarity around direction. They will also carry their own investigative workload, and act as Senior Investigating Officer (SIO) for more complex cases.
- **4.5** The investigation team also carry out daily checks on high-speed offences, those who pose the most risk on our roads. Developing intelligence on the individuals to ensure they are fast tracked through the court system to remove them from our roads, or targeting them via warning markers on their vehicles, which can be directed internally within the police to respond to. The Road Safety investigations Team Supervisor will triage and identify the most significant risks and prioritise investigations accordingly.
- **4.6** For our youth drivers, 17 and under, youth court files are required that must be submitted to the Youth Offending teams for Youth Court. These are prepared by our Police Officers and evidentially reviewed by the PIP 2 supervisors
- 4.7 Police Officers are used to giving advice to Police Staff on points of law, to assist

with investigations, and to carry out investigations including arrests, property search and seizure using their sworn powers and subsequent interviews. The Road Safety Investigations Team Supervisor will plan and co-ordinate this activity on a daily basis, presenting to Force tasking and Tasking and Co-ordination group where additional force resources are required, warrants etc.

- **4.8** The day to day oversight of this team of 6 investigators has grown beyond the capabilities of the Road Safety Team managers with regard to PIP offences and their investigative workload, review and decision making, involvement in additional force taskings meetings, operational planning, and welfare and administrative requirements that come with direct staff line management has grown to the point that an additional section supervisor for this team is now required.
- **4.9** The investigator team is the only team that does not have their own supervisor under the current road safety team structure. The individuals in the team are fully funded by VZSW Cost Recovery, as are the managers who would line manage the post. There is a clear and ethical rationale to fund the post from VZSW cost recovery activity.

5.0 FINANCIAL REQUEST

- 5.1 The post will be recruited by Devon & Cornwall Police
- **5.2** There will be a level of cost recovery through the award of court related costs for convictions by the team.

6.0 IMPLEMENTATION TIMESCALE

- 6.1 Subject to final approval from Vision Zero South West Governance Board, the following outlines the anticipated key project milestones:
 - If approved this would then be presented to the Work Force Demand Group for the force sitting at the end of September 2024.
 - Change in Design for post to be submitted for Force approval on successful Work Force Demand Group approval.
 - Job Evaluation Process to be followed to establish grading for the post. No such equivalent post exists in Devon & Cornwall.
 - It is anticipated the Road Safety Investigations Team Supervisor will be in post by January 2025.

7.0 NEXT STEPS

- **7.1** Subject to Board approval, the next steps will be to adjust the in year financial plan with the approved revenue costs of this post.
- 7.2 An update on the output and evaluation of the role will be presented to the VZSW Board in December 2025.

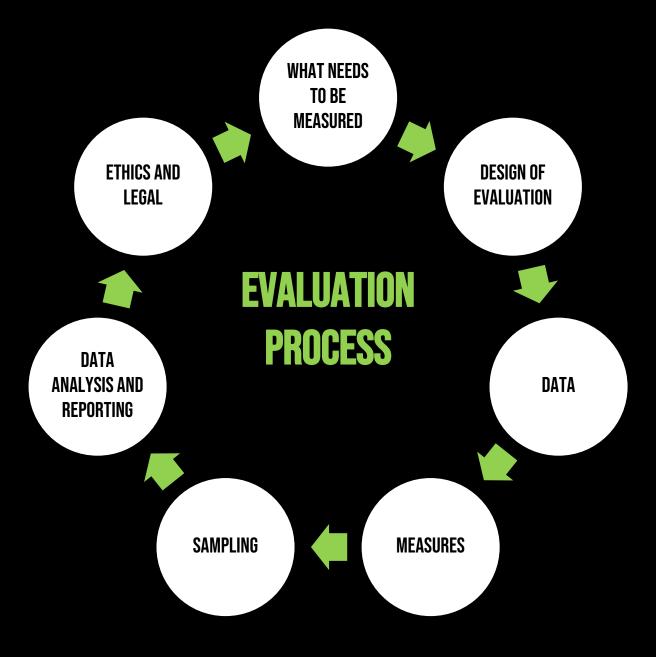
